GENERAL INFORMATION

This is a translated excerpt of the official document "KRISTIANSUND OG NORDMØRE HAVN IKS, HAVNEREGULATIV 2025, VILKÅR OG PRISER," which is in Norwegian. In case of any disputes, the Norwegian version will prevail.

All rates are in Norwegian kroner (NOK) and exclude value-added tax (VAT).

FAIRWAY DUES

Regulation on fairway dues

All vessels calling a port within the inter-municipal area of the Port of Kristiansund and Nordmøre IMC must pay fairway dues to support the harbour's operational costs related to public safety and accessibility.

Fairway dues is charged per call. In case of multiple calls during the same day from 00:00 to 24:00, the fee is imposed only once.

Fairway dues for coastal steamer and cruise ships:

QUAY FEE

Calculated based on the vessel's gross tonnage (BT), the quay fee covers the vessel's use of port and mooring facilities. The minimum fee applies to each unique vessel. If a vessel remains docked beyond 24 hours and changes berth within the port, the fee recalculates based on half or full-day rates. 6 hours or less will be counted as half a day.

Minimum fee: NOK 284 per day.

ISPS SECURITY FEE

A security fee of 30% of the quay fee is charged for vessels entering ISPS-approved port sections, covering the costs of security investments and operations. Additional mandatory fees apply to international passenger traffic.



MANDATORY SECURITY FEE

To cover the harbour's costs for the required security of the passenger traffic in the port, a mandatory security fee is charged, in addition to the port fee, at the following rates:

Security fee for vessels in international traffic: NOK 16 per passenger.

Minimum security fee for ISPS calls requiring security staff: NOK 13 000 per call.

DISCOUNTS (LNG AND ESI)

LNG discount

Vessels using LNG may apply for a 20% quay fee discount. Subject to approval.

• Environmental discount (ESI)

Vessels with an ESI score of 50+ qualify for a fairway due discount (30%). For cruise vessels, an additional quay fee discount based on ESI score applies:
